6. New Business

a) The Minister of Environment Meeting has been cancelled for June 28th, 2016 with our Board of Directors
b) GEEP Electronics has temporally decreased the incentive payment to Alberta CARE by 20%, Alberta CARE spit the difference with the members.

- c) The Landfill Cost Comparisons Survey results were sent out to the members.
- d) Two Alberta Job Grant and Summer Temporary Employment Program.
Art Sawatzky, Peace Regional Waste has been approved for 3 students under this grant, recouping \$7.00 per hour.
Dennis Lang, North Peace Regional Landfill, has hired in the past, but this year the Commissions are not being accepted under the STEP program.
- e) Alberta Recycling Conference 2016' is being held in Athabasca. Members encouraged to book hotel rooms as soon as possible due to construction crews booking for Fort McMurray and Alpac shutting down for the month of September.
- f) The Alberta Recycling Spring Seminar for 2017' will be held at the Olds College.
- g) Tom Moore is now the Manager of the Westlock Regional Waste Commission and will remain as a member of Alberta CARE for Region 2 & 3.

8. Round Table

Amy Horne reported that the RCA was not successful with having a meeting with the Minister of Environment & Parks. The RCA decided to meet with the respective MLAs. The meeting with Wayne Drysdale went really well. The volume at the Eco Centre has had a significant decrease and the curb side recycling is down 100 metric tons. They are holding off shipping their Styrofoam because in the past, they received 28 cents a pound, and currently they would only receive 8 cents a pound. Aquatera is still having issues with GEEP regarding cages. Some cages have to be put together when they are received, they are missing hinges and have glass in the bottom of the cage.

Dennis Lang reported that he uses a sea can without cages. All heavy items at the bottom and then the light ones on the top. It has worked well and he will continue with this method and with Recycle Logic. Dennis Zahacy reported that they have changed to GEEP and gotten rid of the sea can method, which can be a health and safety issue. Art Sawatzky uses the sea can method and will remain with Recycle Logic.

Art Sawatzky reported that volume is down for oil and gas waste and their operation is subsidized by oilfield waste. Peace River has a blue bag curbside recycling program. The processor came to them to bale the recyclables and then send it to the processors. It seems to be working. They are promoting backyard composting. Art Sawatzky and Environment and Parks came together to speak in the community and schools about the importance of backyard composting. They will be building a Class II composting pad.

Dennis Lang reported that volumes are down, but are still busy. He attended a County tradeshow and promoted battery recycling (small ones). They can be very dangerous and cause fires. The key to success is education. Dennis attended the SWANA Conference in Calgary in May and will be attending the Alberta CARE Conference in Athabasca.

Nels Nelson reported that the volume is down at Long Lake Regional Landfill, but recently, 2 large elevators were torn down and the waste could not be burned so it was buried, which brought the volume up to last year's stats. There was no asbestos in the waste, but lots of grain dust.

Jennifer Besinger reported that they have put forward community incentives for organic diversion. The County is subsidizing the cost of digesters and composters. The cost of the digester to the County is \$120.00 and to the community it is \$60.00. The cost of the earth machine is \$60.00 and to the community it is \$30.00. They are collecting organic waste in the public works building.

Doug Dallyn reported that Northern Sunrise County has switched over to curbside pickup and it is going well. It was cheaper to have this than the County doing it themselves.
